FACULTY SENATE MINUTES

May 5, 2008

The Faculty Senate of Eastern Kentucky University met on Monday, May 5, 2008, in the South Room of the Keen Johnson Building. Senator Eakin called the eighth meeting of the academic year to order at approximately 3:30 p.m.

APPROVAL OF MINUTES:

The April 7, 2008 minutes were approved as written.

PRESIDENT'S REPORT: Senator Whitlock

Senator Whitlock announced that EKU's Board of Regents proposed an 8% tuition increase. This is in comparison to Murray's proposed 6% tuition increase and the KTCTS system's 13% increase. CPE will act on the tuition recommendations on Friday, May 9th.

With the 3% budget cut earlier, and the additional 3% cut on remaining funds, which amounted to approximately \$4.5 million, the proposed 8% tuition increase will not generate enough funds to cover all necessary expenses to keep the University operational. Therefore, there will need to be some reallocation of existing resources. In the last six years on this campus, FTE student enrollment has increased about 3%, faculty lines have increased 7.1%, and staff lines have increased 7.4%. So staff positions have increased slightly more than faculty positions. As such, there may need to be a much firmer line taken on keeping positions frozen in staff lines.

One of the more significant things on the budget process is that development of the 09-10 budget will begin during the summer rather than waiting until mid-winter next year to start the process. The Faculty Senate Budget Committee will be consulted in that process.

Last time Senator Whitlock misspoke on the insurance. The new health plan went into effect July 1 and will run through December 31st. Another enrollment will be held in January and the new plan will run from January 1 through December 31st. President Whitlock met with the Benefits Committee after realizing the mistake, and the committee made a good suggestion which was quickly implemented. On the high PPO plan, it could be possible that an individual could be exposed to the maximum out-of-pocket expense for the annual year within that six month period. If this occurs, the University has agreed to split the cost so that an individual would only be responsible for half of that amount during the six month period.

Senator Whitlock announced that while salary compensation has not been determined for the coming year, he hopes to have the resources available to do approximately \$500 across the board for everyone and then on top of that a percentage amount, all of which would be added to the base salary. This kind of hybrid approach both recognizes the realities for the lower paid people and will also recognize the need to minimize compression and to try to do everything possible for those folks who may be approaching retirement.

The other thing this hybrid approach would do is to help this institution make up some ground that has been lost since 1998. In 1998 Eastern paid its faculty at 105% of the benchmark and was the highest paid comprehensive institution in the state; and now Eastern is down to mid-range. Senator Whitlock stated that one of his goals is to once again have Eastern be listed as one of the highest paid comprehensive institutions in the state.

Another issue that the ECU community needs to be thinking about is degree productivity, because it will probably play a significant factor in future funding. One area that Eastern has potential growth opportunity in is the area of completer degrees. There are a large number of adults in the population that are close to degree completion. ECU has a Bachelor of Individualized Studies for those folks; other institutions have similar degrees but with different names. From 1999 through 2006 Western graduated 1267 people with such degrees, Murray was in the 500-600 range, and Eastern graduated 48 such folks. Based on these figures, there may be considerable growth potential in this area for ECU.

NEW BUSINESS:

Budget Committee Membership Motion. Senator McKenney introduced the motion. Senator Winslow moved to approve the recommended change to the Budget Committee membership (listed below), seconded by Senator Johnson. The majority were in favor and the motion carried. This motion will need to be approved by the Faculty-at-Large at the August 2008 convocation.

The following change should be made in the Faculty Handbook, Part VII (Organization of the Faculty of Eastern Kentucky University), VII. The Faculty Senate, E. Committees of the Senate, 5. Committee on the Budget:

Under section (a), which lists membership of the committee, remove the following sentence: "The Vice President for Government Relations and Planning shall serve as a non-voting member of the Committee." Replace it with this sentence: "The Vice President for Financial Affairs shall serve as a non-voting member of the Committee."

Council on Academic Affairs Report. Dr. Janna Vice reported for Senator Piercey.

1. Computer Science (B.S.) - Program Revision - add new option in Computer Security
2. Accelerated BBA/MBA Program - New Program
3. Course Syllabus Policy (with attached CAA's approved revisions)

Senator Collins moved approval of item #1 (Computer Science B.S. Program revision), seconded by Senator Styer. The majority were in favor and the motion carried.

Senator Robles moved approval of item #2 (new Accelerated BBA/MBA Program), seconded by Senator Winslow. The majority were in favor and the motion carried.

Senator Robles moved approval of item #3 (Syllabus Policy), seconded by Senator Winslow.

Some of the issues raised in discussing the syllabus policy included:

- "written communication" needs to be updated to reflect 100% online courses to something like "written or electronic communication"
- Syllabus should be distributed by the first or second work day of the University - listed as such because if a class meets once a week it's unacceptable to not receive the syllabus until the second week. However, some senators felt the "second work day of the University" wasn't defined well and therefore could be problematic
- The course drop date was pushed back by two weeks so "mid-term of the semester", should be rephrased to account for the change in the drop date.
- Nonstandard courses (ex: five week courses, ITV or online courses at extended sites) - having graded assignments in time to report mid-term grades can be problematic.
- This policy doesn't state that it's for undergraduate students only. If it isn't stated then it will be interpreted that graduate students are included as part of this policy. That needs to be clarified.
- The policy should be consistent throughout. On page 3 under "course instructor" it says distribute a complete syllabus to students no later than the first course meeting". That should be consistent throughout the document.

Senator Johnson moved to postpone further discussion until the fall semester and requested that an updated policy be provided prior to the meeting, seconded by Senator Borrowski. The majority were in favor and the motion carried. Senator Eakin encouraged everyone to read the syllabus policy and direct any feedback to Dr. Vice as soon as possible.

Policy on Faculty Qualifications. Dr. Sherry Robinson was in attendance to discuss the Policy on Faculty Qualifications which was emailed to the Senators earlier last week. The Provost Council will be discussing this policy at their next meeting later this week. It is possible that the Provost Council may enact this as an interim policy, but even if they do, the policy will still come back to the Senate for a vote in the fall. Anyone with comments or questions should share those with Dr. Robinson prior to the Provost Council.

Senator Redmond indicated that his department is against this policy as currently written. His department employs a large number of graduate and undergraduate students to fill lab positions, and this policy would prevent that as currently written.

Senator Waters stated that there should be additional faculty representation available when the Provost Council discusses this issue. Faculty haven't had enough time to adequately discuss this issue before the Provost Council is scheduled to act on it.

GENERAL & STANDING COMMITTEE REPORTS

EXECUTIVE COMMITTEE REPORT: Senator Eakin

Parliamentarian Miller took a moment to present a gavel of appreciation to Senator Eakin for his service as chair for the last two years.

Senator Eakin expressed his appreciation to the Senate for their hard work and collegiality during his tenure as chair. He also expressed thanks to Parliamentarian Bob Miller and Secretary Pauletta King for their service throughout the last two years.

In his written report to the Senate, Senator Eakin shared the following.

Dr. Jaleh Rezaie was in attendance at the last Executive Committee meeting to discuss the proposed Graduate Faculty Status policy. The draft policy will be distributed to the graduate coordinators who will in turn share with their colleagues. The intent is to present this policy to the Senate in the fall. Faculty will also have an opportunity to provide additional feedback at that time.

SGA shared the Bulletin Board policy draft and the Posted Item Stamping Policy Guidelines draft with the University attorney, at the request of the Executive Committee. Student Services asked the University counsel to postpone reviewing the policies until they have an opportunity to respond. However, the SGA reports that Student Services has had a continued presence over the years in this discussion. Dr Eakin reported that he had a long discussion with Mike Reagle, AVP of Student Affairs concerning the Bulletin Board Policy. Reference to a statement in the Faculty Handbook has been referenced regularly. Perhaps the best solution is to eliminate that statement from the faculty handbook and place it as the level of university policy.

SGA submitted an updated Dead Week Policy which will be reviewed by the Executive Committee at the August 25 meeting.

Senator Eakin expressed his appreciation to David Fifer and the SGA for working with the faculty on a number of issues this year. Such faculty/student/staff work groups represent an important step toward shared governance at EKU.

REPORT FROM FACULTY REGENT: Senator Frisbie

Senator Frisbie reported that the Board met for a regular quarterly meeting on April 22, 2008.

Informational Items included the following:

- The Board heard a financial status report for the University. Tuition revenue is running about on pace with last year's, which is a bit below projected tuition revenue.
- The Board heard a report from the chair of the EKU Foundation board. Progress continues on realizing the capital campaign goal of \$25M. The Foundation value is currently at \$22.5M.
- Two representatives from Siemens Building Technologies reported on EKU's performance contract with them. This is an exciting, \$22M, 12-year project. Siemens will provide campus-wide energy efficiency improvements and address deferred maintenance issues in six target buildings (Stratton, Campbell, Burrier, Combs, Coates, and Jones Buildings). These efforts will provide annual energy cost reductions of at least \$2M, which is guaranteed by Siemens. Improvements will target things like more efficient lighting, heating and cooling, and ventilation; and water conservation. Siemens estimates that it can help the University reduce its CO2 emissions by 76M lbs., its nitrogen oxide emissions by 123K lbs., and its emissions of SO2 by 404K lbs. over the life of the contract. This is the largest such contract in the state to date.

Action Items included the following:

- The Board approved all 10 items that came to it from the Council on Academic Affairs.
- The Board approved the tenure and promotion recommendations.

- The Board approved recommendations for emeritus status for five retiring faculty members: Paul Blanchard (Government), Rick Clewett (English & Theatre), Richard Freed (English & Theatre), Un-Chol Shin (Foreign Languages & Humanities), and Richard Givan (Criminal Justice & Police Studies).
- The Board approved two new Foundation Professorships for Elizabeth Hansen (Communications) and Robert Mitchell (Psychology).
- The Board approved a tuition increase for 2008-09 of 8% (tuition and mandatory fees). This will result in an increased charge of \$228 per credit hour for in-state undergraduates (\$246 for graduate students). The increase for out-of-state students will be \$615/credit hour (undergraduate) and \$674/credit hour (graduate students). In addition, the new tuition structure calls for a \$128/credit hour (\$346 for out-of state undergraduate students) for each credit hour at 17 or more hours per semester. The corresponding surcharge for graduate students will be \$184/credit hour (\$505 for out-of-state graduate students) for each hour at 13 or more hours per semester.
- The Board approved residence hall rate increases that average 10%. This will result in increased costs to students of \$216-256 for a single room, depending on the particular facility, and increases of \$103-175 for double rooms. Student Affairs intends to use some of the increased revenue to carry out some maintenance and upgrade work in the residence halls.
- The Board approved a dining rate increase of 4.5% for 2008-09. This rate was negotiated with Aramark some time ago, and looks particularly good in light of more recent increases in food and other prices.
- The Board approved the re-engagement of Deloitte and Touche as external auditors for the University for 2008-09.

The Board will next convene on June 2, 2008 for a regular quarterly meeting.

REPORT FROM COSFL: Senator McKenney

Senator McKenney reported that this year COSFL met on September 17th and on January 12th. Representative Harry Moberly was invited to speak at the January meeting regarding the state budget process. Also at that meeting, Brad Cowgill gave an excellent presentation.

COSFL will hold the last meeting of the year in June.

REPORT FROM THE PROVOST: Senator Piercey

Senator Piercey shared the following in his written report to the Senate.

In the area of academic affairs policy and governance, the following items represent draft policies currently in the review process:

- Policy 4.1.2 (Course Syllabi) has been reviewed for a first reading by the Faculty Senate. The policy was approved with revisions by the Council on Academic Affairs.
- Policy 4.6.1 (Determination of Qualifications for Teaching Faculty) has been reviewed a third time by the Provost Council. The policy was supported and disseminated to the Chairs Association and the Faculty Senate for review.
- Policy 4.3.4 (Joint Curricular, Collaborative, and Consortial Agreements) has not been worked on since the last report to the Faculty Senate.
- Policy 1.1.1 (Formulation and Adoption of University Policies) continues to be vetted across campus. Dr. Sherry Robinson met informally with members of the Faculty Welfare Committee to discuss possible revisions. As soon as it is ready, a revised draft will be re-submitted to Faculty Senate.

All new or revised policies are presented as drafts until they are approved by the Board of Regents.

Editorial clarifications for Policy 4.6.4 (Promotion and Tenure) will be sent to University Counsel for review. As soon as possible, the clarifications and the revised policy will be published to the academic community. A small work group consisting of someone from Faculty Senate who previously worked on the promotion and tenure policy and of an administrator who works with implementation on the policy will begin evaluating some potential amendments to Policy 4.6.4.

In the area of Graduate Education and Analysis, comments are being sought on a draft of the Strategic Plan for Graduate Education and Research. Formal invitations for review have been sent to all Graduate program coordinators, chairs, deans and members of the Graduate Council. The draft plan is posted for comment on the web at <http://ekuculture.ning.com>. A special thanks to faculty members JoAnn Ewalt, Derek Paulsen, Marcel Robles, Sharon Shasby, and Melinda Wilder for their contributions to the development of EKU's Strategic Plan.

In the area of Institutional Effectiveness, Dr. E. J. Keeley (with Dr. Kendra Stewart and Corey Bray) presented a University Strategic Plan progress report to the Board of Regents. Dr. Keeley continues to collaborate on the Graduate Education & Research and Powell Student Center strategic plans. The Program Review Work Group is finalizing its plan to reform program review as part of the Institutional Effectiveness process. Dr. Keeley continues to refine the Fall 2008 enrollment forecast based on inputs from a variety of university constituencies.

Internal interviews are being conducted for a QEP Director.

Dr. E. J. Keeley participated in a conference call with SACS to discuss EKU's upcoming Ed.D. in Educational Leadership six-month SACS team review to be held in January or February 2009.

REPORT FROM THE STUDENT GOVERNMENT ASSOCIATION: Alex Combs

As outgoing SGA President, David Fifer was in attendance to review SGA's efforts throughout the past year and to introduce the new SGA President, Alex Combs. The Bulletin Board and Posting Placement Policies are still pending. Both policies were submitted to University Counsel at the suggestion of the Executive Committee. The Colonel path is finished and will be opened officially in the fall semester. Furthermore, renovations have begun on the Herndon Lounge in the Powell Building.

Mr. Fifer thanked the Senators for working closely with SGA throughout the past year. Current Elect SGA President Alex Combs announced his commitment to continue to work closely with the Faculty Senate next year.

In addition, Mr. Combs stated that one of the most important points on SGA's platform for next year is to re-evaluate the orientation classes for all students.

Budget Committee. Senator Ciocca reported that once CPE has determined the budget, EKU's budget should be completed within the next couple of weeks.

Committees on Committees. Senator Foote stated that the committee compiled a report based on the information received from the survey regarding University Committee vacancies, and the report has been shared with the Senate chair.

Welfare Committee. Senator Waters wished to review the last Welfare Committee report as there was insufficient time to do so at the April meeting.

One of the committees' charges this year was to discuss the philosophy and reality of shared governance at Eastern. The committee would like for the EKU community to consider the following two questions in order to facilitate further discussion next year: 1) what does faculty think about shared governance at Eastern at this time? 2) what shared governance model, principles and elements does this faculty want at Eastern.

The committee met twice since the April Senate meeting. Senator Waters thanked President Whitlock for meeting with the committee to discuss benefits issues. She also thanked Dr. Sherry Robinson for meeting with the committee to discuss the proposed policy on policies and how that affects faculty and this academic institution.

Senator Waters expressed her appreciation to her fellow committee members for their hard work and dedication during the past year.

Joint Ad Hoc Committee on Dead Week Policy. Senator Ware reported that a draft of the proposed policy will be reviewed at the August Executive Committee meeting.

Report on Colonel 1 Card. Senator Noblitt reported that the new Colonel 1 Cards have been distributed to current students. As freshmen come to campus, they will start getting these cards as part of their orientation, and there will be on-going marketing afterwards to clarify questions for students. As previously reported, Senator Noblitt reiterated the need to continue to assess this program for students and that the assessment should be independent of anyone related to the Colonel 1 Card program. She further stated that SGA would be the most logical choice for the assessment and that she would like to work closely with SGA next year to hopefully develop a type of assessment for implementation about this same time next year.

As far as faculty cards, faculty will get new cards as was reported last month. This is only because the new card readers can't read the old cards. There will also be printing on the cards that identify faculty are public employees for the state of Kentucky so that faculty can receive government employee discounts at various locations.

When asked if Model Laboratory students would be receiving the new cards as well, Senator Noblitt indicated that she would have to look into that and report back later.

Senator Eakin thanked Senator Noblitt for outstanding work on the Colonel 1 Card issue.

RE: Subsequent Degrees, Request for Clarification

The catalog policy language regarding Subsequent Degrees (section **Subsequent Degrees**, pg. 49 of the Undergraduate Catalog) is currently being interpreted by the University community in two distinct ways. This is resulting in inconsistent application of the policy. Enrollment Management therefore requests a clarification of this policy from the CAA and an endorsement of an editorial revision of the catalog text to reflect the clarification. The language in question notes, **“A subsequent baccalaureate degree requires at least 32 approved hours *beyond those required for the earlier degree.*”** (Italics added for emphasis.)

Clarifications Requested:

I. Subsequent Degree Requirements

The two differing interpretations of the current catalog language are as follows. It is requested that the CAA endorse one interpretation for university wide application.

Interpretation A: *Hours earned prior to the awarding of the first baccalaureate degree may be counted toward the 160 hour minimum required to earn a subsequent baccalaureate degree.*

Interpretation B: *The 32 hours required for a subsequent baccalaureate degree must be earned after the first baccalaureate degree is awarded; regardless of the number of hours earned at the time the first degree.*

II. General Study Degree as Subsequent Baccalaureate

It is additionally requested that the CAA clarify the policy regarding the use of General Studies Degrees as a subsequent baccalaureate degree.

Can a General Studies degree be earned as a subsequent baccalaureate degree?

Historical note: Original CAA paperwork creating the General Studies Degree stated that it could not be a subsequent degree. This proposal was withdrawn; the final approving paperwork did not address the issue. The question remains unresolved and confusion results.

Justification for First-Time Freshmen Admissions policy

The language of the current general requirements for undergraduate admission includes various categories of admission. These categories include “full admission,” “provisional admission,” “probationary admission,” and “special admissions.” The terms are difficult to understand and interpret for students and parents. For example, the term “probationary” admission indicates that the student is “under probation” and is not fully admitted to the University, which is not the case. To better recruit and retain students, the language will now have three admission categories: “full” admission for all students meeting the current requirements for full admission status; “admission with conditions” for admitted students with developmental education or pre-college curriculum needs, or otherwise do not meet “standard” or “full” admission criteria; and special admissions. Different programs, coursework and/or services will be provided for those admitted in the “admissions with conditions” categories. This allows for flexibility of adding service and program requirements and recommendations as new programs and services are developed for students “at high risk” of not persisting at the University.

The conditions and criteria for admission may vary depending on undergraduate or graduate status, but all applicants must provide an application and evidence of appropriate scholastic achievement through prior educational experience. Additionally, certain degree programs have special admission requirements. Admission to the University does not mean imply automatic admission to a degree program.

This regulation outlines conditions and criteria for admission to ECU as a first-time freshman.

The purpose of this regulation is to outline the criteria and categories for admission to the University as a freshman.

Criteria

ADMISSION REQUIREMENTS FOR FIRST-TIME FRESHMEN

Students will be admitted into one of three categories: full admission, admission with conditions, and special admissions.

FULL ADMISSION

Students admitted with full admission must have

- graduated from an accredited high school and earned a minimum cumulative high school grade point average of 2.0 on a 4.0 scale
- or**
- received a General Equivalency Diploma (GED)
- or**
- completed an ECU approved home-school or distance learning high school program
- and**

Re: Executive Committee Chair's Report

It is a pleasure to welcome everyone to our first Faculty Senate meeting of 2008-2009, and I look forward to working with every one of you this year. I apologize for the length of this first report but much has happened since we last met in May; hence the plethora of updates.

The Executive Committee met on August 25, 2008. Agenda items and information to be presented at the September Faculty Senate are as follows:

- EKU Staff Council Chair, Beverly Burrus, presented the EKU Rides program and asked that Senators encourage faculty to participate in the program. In addition to the economic and environmental benefits of the social carpooling system, prime parking spots have been designated for EKU Rides participants. Faculty, staff, and students may sign up for the program on Facebook or at www.rides.eku.edu.
- The New Senator Orientation for 2008-2009 is scheduled for September 8 at the Faculty Lounge in Keen Johnson. Thank you to Senators Robles, Randles, and Ware, members of last year's Ad Hoc Committee on New Senator Orientation, for continuing to serve and for organizing this year's orientation. The motion to add the Committee for New Senator Orientation to the Faculty Handbook was approved by the Faculty-at-large at the August 13 meeting and a new committee will be voted on at the May organizational meeting of the Senate.
- Dr. Sherry Robinson presented an update on the status of the Policy on Faculty Qualifications. Work is continuing on the draft of this policy, and a task force was appointed to work with Dr. Robinson. Serving on the task force are Senators Collins, Kristofik, and Taylor.
- Work continues on the Policy on Policies and a draft will be available for review in the near future. Because a number of policies are in the draft and consideration stage, Senator Ware asked that policy updates be included as a standing topic on the Executive Committee agenda. Dr. Robinson agreed to attend and to keep us informed.
- Senator Ware presented an update provided by Dr. Jaleh Rezaie on the status of the Graduate Faculty policy. The policy is still in the review stage and input from faculty will be elicited during the fall semester. A draft for presentation and consideration should be forthcoming near the end of the year or early 2009.
- SGA Vice President, Lindsey Cross, presented a revised draft of the Dead Week policy. The Executive Committee provided suggestions and feedback based on faculty and curriculum concerns. Ms. Cross took these suggestions under advisement; she will bring a revised draft policy to the Executive Committee at the September 22 meeting.
- Senator Ware presented a report from SGA President, Alex Combs, on the status of the policy on bulletin boards, stamping, and language guidelines. The policy is under review by university counsel. It will be presented to the Executive Committee with recommendations for consideration when the review is complete.
- In response to discussions last spring, President Whitlock is looking into the possibility of providing extension strips for laptop use at Senate meetings. Facilities must check the electrical system in Keen Johnson to see if the additional load can be handled by existing power sources. IT will also be notified of the "dead spots" in wireless access and we will try to address this.

- Senator Ware reported on issues from the June meeting of the Provost Council to be brought before the Faculty Senate at the September 15 meeting.
 1. New standards enacted by the Council on Postsecondary Education (CPE) necessitate revisions in first-time freshmen admissions policy.
 - As of Fall 2009, college readiness standards will be defined as ACT sub-scores of at least 18 for English, 19 for mathematics and 21 for reading, or equivalent SAT scores. Students can also demonstrate readiness based on appropriate scores on placement exams.
 - In order to comply with the new standards, a new policy is needed. Effective Fall 2008, the new policy would provide for three admission categories:
 - a. "full" admission for all students meeting the current requirements for full admission status;
 - b. "admission with conditions" for admitted students with developmental education or pre-college curriculum needs, or who otherwise do not meet full admission criteria; and
 - c. special admissions, for which continued enrollment would require full participation and success in identified retention support programs.
 - In addition to bringing us into compliance with CPE, revisions will assist in our efforts to recruit and retain students. They will allow flexibility in adding service and program requirements and recommendations as new programs and services are developed for "at-risk" students.
 - Because the Board of Regents' September 6 meeting predates the first Faculty Senate meeting of the new academic year, and because the Regents will not meet again until January 2009, a compromise was discussed at the Provost's Council that would facilitate approval of the policies needed to meet the new CPE guidelines.
 - A revised First-Time Freshmen Admissions Policy will be presented to the Board of Regents at the September 6 meeting for their consideration and vote. Said vote will be contingent on formal approval and ratification by the Faculty Senate at its September 15 meeting. Revisions at the Senate would require the policy to come back to the Board.
 - The First-Time Freshmen Admissions Policy was approved by the Board of Regents and will be submitted to the Faculty Senate for discussion and a vote on September 15.
 - Discussion on the First-Time Freshmen Admissions Policy at the Executive Committee included the following:
 - Senator Taylor stated that Western has their own community college and that they divert their lowest scoring students into that community college.
 - Senator Taylor suggested that ECU consider a similar system.
 - He further suggested that ECU should look at acquiring the Richmond Mall as a place for the community college.
 2. Issues were discussed related to the awarding of dual degrees. President Whitlock and Provost Piercey reiterate the university's commitment to encouraging our students to pursue dual majors and multidisciplinary study. However, transcription issues must be addressed in awarding degrees. On September 19, the provost will be meeting with academic officers from around the state to discuss their policies and procedures.
- Dr. Janna Vice will present an update on the status of the Syllabus Policy at the September 15 Faculty Senate meeting. Before the policy goes back to CAA, Dr. Vice has suggested putting together a task force of interested parties for additional faculty input. Senator Dorothy Carter has agreed to serve on this committee.
- The status of subsequent degrees was discussed and will be brought before the Senate as an Informational Item at the September 15 meeting.

- Committee vacancies include the following:
 - Executive Committee replacement (for Bob Shadur) – vote to be held at the September 15 meeting.
 - Committee on Committees replacement (for Vickie Sanchez) – vote to be held at the September 15 meeting.
 - University General Education – Senator Noblitt volunteered to serve on this committee
 - Arlington Board – Senator Flanagan is willing to serve
 - Withdrawal Committee – Senator Schmelzer volunteered to serve on this committee
 - Residency Appeals – need someone to serve on this committee
 - The following members of the Executive Committee agreed to serve as liaisons to standing committees during the coming year: Senator Taylor, Budget Committee; Senator McKenney, Rules Committee; Senator Kristofik, Rights & Responsibilities; Senator Ware, Elections Committee; Senator Collins, Committee on Committees; Senator Johnson, Faculty Welfare Committee. The Ad Hoc Committee liaison will not be chosen until a replacement has been elected for former Senator Shadur's position on the Executive Committee.

- The Committee agreed that For the Good of the Order discussions should be continued. The topic, "What can we do with our advising system to improve student retention," was discussed for the September meeting. All agreed that a goal of FTGOTO discussions should be to conclude with an actionable agenda (e.g., investigate and report back to Senate; resolutions proposed) so that the discussions will be proactive and effective.

- Senator Ware stated that a priority for this year is to see how we can improve communication in ways that facilitate shared governance. Toward that end, she asked Gene Kleppinger to set up a Blackboard for Faculty Senators. A Blackboard can also be established for Senate Standing Committees to assist them with sharing information and online meetings, if desired.

- **NEW BUSINESS:** A draft of an Early Registration for Designated Populations policy was presented at the Provost's Council on September 3. Because this occurred after the Executive Committee meeting on August 25, it is not on the Agenda for the September 15 meeting. However, in the interest of making the information available to faculty in a timely manner, an overview of the status of the policy is presented in this report.
 - A preliminary outline of this policy was presented to the Executive Committee in the spring. It elicited a great deal of comment and the Executive Committee asked that it be reviewed and revised.
 - The revised policy was brought before the Provost's Council. At the September 3 meeting of the Council, it was apparent that faculty members had an interest in this policy and that it would be beneficial if faculty input could be incorporated into deliberations of the proposed policy.
 - A motion was made and approved for the policy draft to be reviewed by the Faculty Senate, with recommendations submitted to the provost's office no later than December 1, 2008.
 - An Ad Hoc Committee on the Early Registration for Designated Populations policy draft has been appointed. Members of the committee include Dr. Steffen Wilson, liaison from Faculty Senate; Dr. Dave Eakin, former Senate Chair; Dr. Linda Frost, Honors Program Director, and Dr. Karin Sehmman, Associate Chair, Music Education.
 - The Early Registration for Designated Populations policy draft shall be made available to all Senators on the Faculty Senate Blackboard.
 - Senators are charged with:
 - presenting the policy to their constituents;
 - preparing a written response summarizing concerns and recommendations;
 - submitting the written response to the Ad Hoc Committee no later than Friday, October 17 (contact information for submitting the response will be posted on the Senate Blackboard).
 - The Ad Hoc Committee will compile a summary report to be presented to the Faculty Senate at the November 10 meeting.
 - A final report will then be submitted to the Office of the Provost for consideration and review.

2 June 2008, Regular Quarterly Meeting of the Board

The Board of Regents met on 2 June 2008 for a regular quarterly meeting. President Whitlock distributed a comprehensive review of that meeting to the university community via email on 5 June, and I will not redo that report here. Rather, I will highlight a couple of items that I think are of interest to the Senate.

During the June meeting, the Board handled the bulk of the budget work for the upcoming year, including approving the \$213 million dollar operating budget for the University, setting the guidelines for salaries and benefits (1.5% + \$500 raises), increasing the faculty/staff scholarship benefit to 12 h per semester, and setting tuition for undergraduates, graduates, and at Model Lab School (e.g., 7% increase for resident undergraduates, 8% increase for resident graduates, 9.5% at Model). Our 2008-09 budget reflects a decrease of \$5 million in state appropriations. The Board had approved tuition increases in the April meeting, subject to approval by the CPE. Even though our proposed tuition increases were less, in dollar amount, than those recommended by the CPE prior to the 2008 legislative session, CPE did not approve our proposed increases (of approximately 8%) in April. Thus, the Board needed to pass revised tuition rates in June. The overall budget package is, I believe, a sound one. I appreciate the efforts of the President to see that a reasonable sum of money was directed toward compensation of faculty and staff, even in financially difficult times. I agree with the President that it is important to help those in the university community whose salaries or wages are lowest, and for whom inflationary pressures are more difficult to withstand. The \$500 across the board raise and the enhanced faculty/staff scholarships are two efforts to do that.

The Board was pleased to learn that ECU will close its capital campaign 9 months early (on 30 September 2008), having reached its goal of \$25 million. On to the next campaign!

The Board approved all 7 items that came to it via the Council of Academic Affairs. These included 3 new programs (professional certificate in Correction Intervention Studies; accelerated "3+2" BBA/MBA ; new major in Globalization & International Affairs) and 3 program revisions (Women and Gender Studies, MAED in Secondary Education, Computer Science).

The Board approved a contract extension of one year for President Whitlock. His contract now continues to July 2011. I was pleased to support this motion for several reasons. First, in less than one year on the job, President Whitlock has helped to bring a sense of calm (but not complacency) to the University. He has guided us through a difficult financial year. He has begun some administrative reorganization and changes to how we conduct business. He has helped us successfully wrap up our capital campaign. Clearly, we are moving ahead effectively. An additional year will allow President Whitlock to undertake additional initiatives that he might not begin or complete otherwise. Second, the President must be evaluated after his second year. With only a three-year contract, the results of that evaluation would be known sometime in his third year, allowing him little time to make adjustments based on that feedback. President Whitlock has expressed his desire that that evaluation be a productive one – built on real and thoughtful input from across the University community. I think we will carry out a much more valuable evaluation because of the lengthened term of office. And, I believe, Doug Whitlock will take the results of his evaluation to heart and he will modify how he leads us over that 3rd and 4th year.

6 September 2008, Regular Quarterly Meeting of the Board

The Board of Regents met on 6 September 2008 for a regular quarterly meeting. President Whitlock distributed a comprehensive review of that meeting to the university community via email on 10 September. I was unable to attend the Board meeting because of a prior, out-of-town commitment. Here, I call your attention to several of the items discussed or acted upon at the meeting.

VP Newsom shared good financial news with the Board: for the fiscal year that ended 30 June, University revenues finished 1% above predicted revenue and expenses totaled only 91% of our projected expenditures. This generated a surplus of \$3.6 million for the year, which helps the University replenish its unrestricted fund balance ("rainy day fund") and which may also permit the University to undertake new, or support on-going, initiatives.

Associate VP Street reported on progress on capital projects that are underway. The Manchester campus building is 80% complete and looks as though it will be completed ahead of schedule (in January 2009). Clay Hall renovations were completed in time for fall move-in, and the intramural field renovations, while somewhat behind schedule, are slated for completion late this fall. Both the new science building and the second phase of the Business and Technology center have run into budget problems, stemming in large measure from the extreme volatility in steel, petroleum, and other commodity prices, which in turn has created a very difficult bidding market. Both projects are being revised in preparation for being sent out to bid later this fall.

Congratulations to VP Joey Foster (University Development), who no longer needs to preface his title with *Interim*.

In action items, the Board:

- Approved two amendments to the Faculty Handbook that came through the Senate (to place the VP for Financial Affairs on the Senate's Budget Committee and to add the New Senator Orientation Committee to the Senate's list of standing committees)
- Approved the merger of the Kentucky Center for History and Politics with the Institute of Government to form the Kentucky Institute of Public Governance and Civic Engagement, under the leadership of Joe Gershtenson
- Approved changes to the language and provisions of the First-Time Freshman Admissions policy, contingent upon approval by the Senate. These revisions are necessary to bring the University into compliance with new CPE requirements. The Board took up this issue before the Senate had a chance to review them because it will not meet again until January, and the University needs to have its policy in place before then. The hope is that the Senate, too, will approve of, and pass, the revisions. If the Senate decides against approval of the proposed revisions, then an alternative will need to be sent to the Board for action.
- Authorized the signing of several financing documents necessary to complete the Siemens Energy Savings Performance Contract. This is an exciting and innovative program in which the University partners with Siemens, at no additional cost to the University, to reduce energy consumption. The program will be paid for with guaranteed energy cost savings. Initially, the program called for \$22 million in savings over a 12-year period. As the partnership details were being worked out, it became clear that additional savings could be achieved, and the scope of the project has been increased to \$27 million, making ours the largest such partnership in Kentucky, and one of the largest in the country.

The Board will next convene in January 2009 for a regular quarterly meeting.

OFFICE OF ACADEMIC AFFAIRS

POLICY AND GOVERNANCE

The following items represent draft policies currently in the review process:

- Policy 4.1.12 (First-time Freshmen Admissions) was submitted to the Board of Regents at their September meeting and approved contingent on Faculty Senate approval.
- Draft Policy 4.1.2 (Course Syllabi) is still under review by the Faculty Senate.
- Draft Policy 4.6.1 (Determination of Qualifications for Faculty Teaching Credit-Bearing Courses) has been reviewed by the Provost Council. The policy has been submitted to the Executive Committee of Faculty Senate and a workgroup was established to address the Policy Definitions. When complete, the policy will be submitted to the Faculty Senate for review.
- Draft Policy 4.3.4 (Joint Curricular, Collaborative, and Consortial Agreements) has not been worked on since the last report to the Faculty Senate.
- Draft Policy 1.1.1 (Policy on Policies) continues to be discussed and revised.

All new or revised policies are considered drafts until they are approved by the Board of Regents.

Revisions to several academic regulations have been submitted to CAA for approval. If approved, these will be sent to Faculty Senate.

A small work group consisting of a representative from Faculty Senate who previously worked on the promotion and tenure policy and of an administrator who works with implementation on the policy will begin evaluating potential amendments to Policy 4.6.4 (Promotion and Tenure).

A new University policy website that will house all University policies is under construction.

DOUBLE MAJORS

While ECU continues to pursue the question of how to appropriately transcript and award diplomas to students who declare two majors leading to two different degrees, President Whitlock and Provost Piercey are committed to allowing students to declare double majors.

On September 19, the Provost will host a meeting of the Chief Academic Officers from all of Kentucky's regional four-year public universities. The topic of double majors is the first item on the agenda. The goal of the discussion will be (a) to identify how the institutions are currently transcribing the double majors and (b) gain a consensus on the appropriate way(s) to reflect the academic credentials of students in this situation.

ENROLLMENT MANAGEMENT

INSTITUTIONAL EFFECTIVENESS AND RESEARCH

CARNEGIE COMMUNITY ENGAGEMENT

The major IE project of the summer was the Carnegie application on Community Engagement. We are very proud of ECU's application, which reflects strong community engagement activities across the Colleges and across the University and its 22-county campus.

PROGRAM REVIEW

In response to the concern expressed by the Faculty Senate and the Chairs Association about the “drudgery” of administrative processes, the Provost charged a work group, chaired by E. J. Keeley, to reform Academic Program Review. As a result, a recommendation was made to the Provost and President to eliminate Program Review and replace it with a Department Review & Showcase.

This new process, called “Department Review and Showcase (DRS)”, will replace Academic Program Review. The DRS will be conducted by a department at the discretion of the Provost and deans, and may be prompted by conditions such as a new program, special and/or noteworthy achievements, enrollment/degree production concerns, accreditation issues, or other concerns regarding quality of the student experience. The DRS process will be piloted in 2008-2009 on a voluntary basis, beginning with the Department of Agriculture.

The work group also recommended annual Institutional Effectiveness progress-reporting process be strengthened for academic departments by requiring development and implementation of an objective and measure(s) for each of the following: (1) teaching effectiveness and (2) advising effectiveness.

ENROLLMENT FORECASTING

A collaborative enrollment forecasting model has been created, calling for a total headcount for Fall 2008 of 16,050 (an increase of more than 200 students, or 1.3% over Fall 2007); as of September 4 the current headcount is 15,850.

VOLUNTARY SYSTEM OF ACCOUNTABILITY

EKU is now a participant in the AASCU/NASULGC Voluntary System of Accountability (VSA) Project. The Voluntary System of Accountability is designed to improve public understanding of how public colleges and universities operate. The College Portrait provides consistent, comparable and transparent information on the characteristics of institutions and students, cost of attendance, student engagement with the learning process, and core educational outcomes. The information is intended for students, families, policy-makers, campus faculty and staff, the general public, and other higher education stakeholders.

STRATEGIC PLANNING

IE has prepared and distributed the University-level KPI requests (on behalf of the Strategic Planning Committee) and progress report materials for the 2008-2009 academic year. Additionally, we have provided extensive support for the College of Education NCATE reaffirmation, presented on the elimination of Program Review at the Chairs’ Retreat, and represented EKU at CPE Meetings on College Level Assessment and “Measuring Up.”

ASSESSMENT & QEP

IE’s assessment staff provided training, consultation and technical assistance for the QEP, is assisting the College of Education in NCATE preparation and revision of their college-wide assessment plan, and is providing twice-weekly TracDat trainings and multiple individual sessions. NSSE (National Survey

of Student Engagement) incentives were awarded to 10 ECU students. Analysis of the 2008 NSSE results is in progress, and ECU is registered to participate in the 2009 administration of NSSE.

By the end of the spring 2008 semester a total of 216 CATs (Critical thinking Assessment Test) were administered to 16 senior level courses throughout the semester. About 5% of the senior population completed the CAT test during that time, and each college's senior population was included in testing. These tests will serve as a baseline of senior level work pre-QEP programs at the University. During late April a request was sent out to several instructors teaching the Academic Orientation classes across campus in hopes of recruiting their class for CAT testing. Thirteen non-GSD 101 Academic Orientation classes agreed to have the CAT test administered during the first three weeks of classes in the fall 2008 semester. In addition, during the fall 2008 semester the GSD 101 classes will also have the CAT test administered to their students. About 700 freshmen will take the CAT test during the fall 2008 semester. A database of all the freshmen is being developed for future assessment. These freshmen CAT tests will serve as the 2008-2009 baseline for entering freshmen.

INSTITUTIONAL RESEARCH

Institutional Research finalized the Spring IDEA (Individuals with Disabilities Education Act) distribution and the Summer IDEA collection. Much of our summer work focused on survey research: we provided consultation, creation, administration, data entry, data analysis, and/or report writing for 13 surveys, including the Summer Flexible Schedule Survey, Summer Sessions 2008 Survey, New Faculty Orientation Surveys, Arts & Sciences Dean Candidate Evaluations, NOVA Surveys, Honors Program Alumni Survey, Health Sciences Alumni and Employer Surveys, Richmond Parks & Recreation Survey, Kentucky State Parks Survey, and the WEKU Listeners Survey. Currently, we are preparing for the University Alumni Surveys to be administered this month; in addition to finalizing plans for a diversity/climate survey to be launched in October. We also spent a considerable amount of time working on updating (both the instrument and the results viewer) the Undergraduate Degree Candidate Survey and the Survey of Graduate Degree Candidates. In addition to our survey research efforts, we fulfilled more than 15 ad hoc data requests across campus (for example, Strategic Planning Key Performance Indicators; Benchmark Comparisons regarding tuition surcharges, and department chair contracts and compensation; Full-Time Enrollment and Student Credit Hour information for both on and extended campuses; Weekly Enrollment Reports; Cooperative Institutional Research Program (CIRP) planning and data analysis; and various Department and Program requests).
